I would like to apologize to the body for the conduct of some of our members at the Tuesday March 9th Union Meeting, especially Mark McDanel, who moved his seat to retreat from the loud behavior. I have spoken to President McPeek about keeping the meeting under control. After some thought, I have decided to make changes to the Referral Policy, which I have full supervision and direction over (Bylaws Article 15 Section 10). Typically, I allow input from membership for decisions made for the referral policy, but I do feel the need to go a direction where those that are willing and want to work rather than those "cherry picking" the next best job. Highlights of the changes are as follows effective **April 1**<sup>st</sup>, **2021**:

- 1. If applicant is rejected or turned down by the contractor, they will receive a turndown.
- 2. You will be allowed 3 turndowns without penalty and you will roll completely off the book for the 4<sup>th</sup> turndown. You must call job line or office to be placed at the bottom of the list within 48 hrs.
- 3. Turndowns will be given for calls deemed 14 days or less and calls for AK Steel.
- 4. Turndowns will be given for calls contractors deem 3 weeks or less to those IBEW 688 members working out of town.

Additionally, after the Tuesday meeting, I was threatened with bodily harm, therefore the union hall will be on lockdown with limited access to the lobby/window area unless access is approved by myself or staff. The safety and wellbeing of our staff is important. I regret any inconvenience this may cause.

Negotiations with employers begin soon, hopefully the negotiating team will have something to bring to you late April for ratification. Please make yourself available to participate in the process once the date has been set.
